#### VI. NEW BUSINESS

#### **STB Minerals**

**LLC Manager:** Due to the untimely passing of LLC Manager Bill Wendt,the LLC managers requested that the POA board approve the re-appointment of Julie Hawley-to complete the Wendt term as manager. Motion by Kitsi, Anelladee  $2^{nd}$ , Julie abstained, Motion passed.

Black Range Definitive Agreement: The signing of a Definitive Agreement between the LLC and Black Range Minerals (BRM) is imminent, and this agreement is likely to contain conditions that will require the involvement of, and/or consent of, the POA, especially issues related to road use and de-annexation of parcels that will be directly affected by mining. Kim asked that we present our concerns up front so that we create a working relationship with the LLC and BRM. Discussion of the POA concerns to present to Black Range included:

1- Access to ranch and the continued maintenance of roads to our current standards.

- 2- Any movement of the Gate Entrance that would also require our trash and mail locations moved would be at their expense.
- 3- Keep agricultural status and Grazing Lease.
- **4-** Any established fencing needs to be maintained or replaced.
- 5- Any noise abatement issues need addressed.
- 6- The POA would want to hold an option open to reclaim or re-annex any properties bought by Black Range back into the POA.

#### **LEC Subcommittee-**Chair: Kitsi Atkinson

Kitsi would like to have a committee established "group in progress" for the purpose of reviewing the LEC documents by the Annual meeting in June. She will draft an email blast for the board to review directed toward the membership asking for any members willing to be on committee.
