Infrastructure Report

Roads: One note on winter snow removal: Even though we are not in dire financial straights that we were a few years ago, there are still some roads that we don't normally plow in the winter, especially those that drift at the slightest breeze. If you want to go to your property, or if you have it for sale, we will still clear it on demand. If it is for sale, please let your Realtor know to check with us first before bringing a potential buyer out.

- After foregoing any re-gravel in the summer of 2016, we did some "emergency" re-gravel in the fall, spending \$5,000 on some places where the underlying rocks were coming through the road base. This was done to make snow plowing and subsequent grading easier and potentially less damaging to the blades.
- For 2017, we have approved re-graveling approximately 2 miles of roads for an estimated cost of a little under \$18,000. If you've been on the Ranch, you can see that this work has already started.
- We have also been working on a 3 year plan, which would be this year 2017 through 2019. If you want to see those roads that might affect you, I have a map depicting proposed re graveling by year. I'll also make the tentative 2018/2019 plans a part of this report so it will be show up in the minutes. See the Map on page 6.

Security: New entry signs have been ordered, and one has been placed on the fence outside the gate. "Private Roads and Property. No Trespassing. Video Surveillance. Violators will be prosecuted." A second sign will be placed on a sign post inside the gate that says: "No BLM Access. Hunting with Land Owner Permission Only". That will be put up next week.

- A question was raised at the last Annual Meeting about improving security through other means. The Board did look at other options such as recording gate codes used, camera in keypad, and real time camera surveillance. It was decided that the cost wasn't justified at this time, but could be looked at again in the future if improved signage and after-the-fact video wasn't enough to deter any violators. However, in order for any video surveillance to work, we need to be able to identify vehicles that belong on the Ranch. That means using your hang tags. We have a new supply of hang tags if yours are lost or just brittle because of age. See me after meeting. I also have some gate remotes for sale, etc.
- New Owner gate code for 2017/2018 is 2170. You can use it now and the old code will be removed after 7/1/2017. The dumpster enclosure code will be changed sometime on 7/1/2017.

Trash: If you saw the recent newsletter, you saw an article about a bear getting into the dumpsters, spreading trash, and damaging the dumpster enclosure. Although this bear was able to knock the bar out of the way, please remember to secure the dumpsters when you put trash in them. It will normally at least slow down a bear getting into the dumpsters.

- We will be making repairs to the enclosure in the next few weeks to repair the damage from the latest bear attack as well as the normal wear and tear on the pickets. Broken pickets will be replaced, nails in existing pickets will be supplemented by screws, and stain will be applied.
- We are still making do with 4 dumpsters open all year. They are normally full by the time they are emptied every two weeks.

Annual Meeting Snippets Con't

RECYCLE: Please do your part in putting metal, including tin and aluminum cans, and any other scrap metal in the metal recycling dumpster, and break down boxes before putting them in the dumpsters so they take up less room. There's almost nothing more frustrating than to find the dumpsters full, but half of a dumpster is taken up by large boxes that have not been broken down. Even better, please consider taking your recycling cardboard by taking it into Cañon City when you go. Michael Omohundro asked for members to pick up trash that has blown out of the dumpsters and/or enclosure.

Cisterns...TVFD is no longer willing to sell us a metal tank for use as a cistern, offing instead a fiberglass tank. Our experience with the fiberglass tanks, even the ones in fairly good shape (which this one wasn't) has not been good. Therefore, we looking at installing 2 1,500 gallon plastic water cisterns in tandem at the same spot where the metal tank was to go.

Communications Report

Website...SSL encryption has been added to the website for the protection of the users. That means you should use https instead of http in the URL, and you should see the lock symbol in the address bar indicating that encryption is in use.

• We've had a lot of registration attempts using fake IDs recently on the website. Most of these are from overseas, in particular Russian with "advertising" with cryllic characters, so I've been playing whack-a-mole blocking not just individual IP addresses, but whole overseas networks. Bottom line, if you happen to be traveling overseas and try to access the website, you may find that you're unable to connect. Please be understanding if you find yourself in that situation.



MEMBER COMMENTS:

- Question was asked as to the status of Western Uranium's intent on finalizing the purchase of minerals on STB. Answer: July 28th, 2017 is the date when Western Uranium has the option to finalize their Letter of Intent. They contacted the STB Minerals board on June 19, 2017 to discuss negotiations
- What is the **best procedures for road kill**? **Answer:** notify DOW within 48 hours. You can possess edible portions only, no antlers.
- What are the **laws pertaining to hunting off private roads? Answer:** There are no laws on whether you can shoot off of private roads. However, herding animals from any road is illegal.

Annual Meeting Guest Speakers...

Bob Carochi - Colorado Department of Wildlife

Bob has been a Game Warden for 20 years, in Fremont County/Canon City for 13-14 years. The district is split up by the Arkansas River. Bob covers north of the river and Zach Holder covers south of the river.

Predator Management & Deer Survival Study - A recent 9 year study has shown that the deer population in Colorado is on the decrease. This current study is being done to see what is causing this decrease.

For the current study, DOW has radio-collared 2000 does and fawns. The deer are caught either by net from a helicopter, deer traps, or dart guns. They are then measured, weighed and collared. The collars fall off the fawns after 6 months to 1 year to allow for neck growth. The collars are monitored with a signal or GPS. The deer are considered dead when there has been no movement for 6-8 hours. The collars are then retrieved. There is a high mortality rate due to mountain lions kills.

This 3 year study includes deer population both north and south of the Arkansas River. The plan is to increase mountain lion harvest and decrease deer harvest north of the river, then flip flop in subsequent years south of the river, to see what effect this will have on the deer population in each area. Mountain Lion have also been caught and collared for this study via traps and dogs. Their movement and mortality are monitored by GPS.

Gordon Grosslight, Fire Chief - Tallahassee Volunteer Fire Department (TVFD)

The TVFD is now qualified to fight structure fires. They are now a fire district and cover 325 square miles. As of April 2017, 5 of their 6 stations are now ISO rating recognized. They have a 7 member EMT team. Most of their equipment is either donated or purchased at a reduced price. They are asking for additional volunteers to complete training. It is important for each resident to make a plan for evacuation and mitigation. The question was asked what it would take to get an ISO rating for the STB station. The answer is 1.1 acres has to be deeded to TVFD where the station is located. The station must house more than 1 piece of equipment. It needs 2 trucks (type 1 and type 6) and a water tenderer. It needs access to 4000 gallons of water within 5 minutes. It needs trained local volunteers for engagement. They are asking for additional volunteers to complete training for the entire fire district.

Rick Romano - USDA, Natural Resources Conservation Service

There is a program available to help land owners with conservation of their land. It offers free technical advice and possible financial assistance to make environmental improvements to your land such as improved water and air quality, conserved ground and surface water, reduced soil erosion and sedimentation or improved or created wildlife habitat. They will help you with applying for the program and if you are approved, they will give you the specifications of the conservation work to be done. Once the work is completed and inspected, you will be compensated for the work done.
