### Quick Communications... Free - \$1 Million

Now that I have your attention: One of the topics discussed by those in attendance at last year's annual meeting was how to improve security on the Ranch. Several ideas were thrown out, including a live camera feed of those entering and leaving, recording of gate codes entered, etc.

But one of the simplest ways we can use is for each of us to look out for each other. But, then you don't know if that or that vehicle belongs on the Ranch, and whether it belongs to an owner or not.

That's why the use of **hang tags** was started shortly after the POA was turned over to the owners. However, a quick review of images from the gate camera —yes, someone does look at them—shows that many owners, of those that can be recognized, are not using their hang tags. So, please, if you have your hang tags, use them. If your hang tags are damaged, or lost, drop a note to hangtags@southtbar.com along with how many you need and we'll send you new ones.

Thanks. And about the \$1 million, just call it a bait and switch. Maybe we got your attention anyway.

### 2017 Board of Directors - Consider your Nomination

There are many challenges facing the South T-Bar Ranch Property Owners Association and enthusiastic, dedicated volunteers are needed to enable the POA meet those challenges. Property owners on South T-Bar and neighboring properties are eligible to serve. You don't have to be living on the Ranch to be on the Board of Directors, and you don't have to be physically present for the Board Meetings – all meetings are held via conference call.

There are ten positions on the Board. The term of membership is two years, with five terms typically expiring each year. In order to win election to the Board, a candidate must receive votes from at least 50% of the POA members eligible to vote in the election, either by attendance in person or by proxy. The Owners elect the Board, and the Board then elects the Officers, usually from among themselves.

Board Members are required by law to:

(1) act in the best interests of the POA, (2) act in an informed manner, and (3) act in good faith.

In addition, Board Members should:

- (1) plan to attend as many Board Meetings as possible, either in person or by phone,
- (2) expect to spend some time outside the meetings on POA business,
- (3) be willing to check your e-mail regularly, and

(4) have a deep and abiding love for this beautiful place we call South T-Bar.

If this describes you or someone you know, please nominate that person for the Board by filling out the form and returning it. If the nomination is for yourself, include a short resume indicating why you want to serve on the Board and any relevant experience you may have. If the nomination is for someone else, the current Board will contact that person and ask for a resume. A nomination can also be submitted via e-mail or on-line from the South T-Bar web site. Nominations will be accepted from the floor at the meeting, but in order for a name to be listed on the printed ballot and to have a resume included in the Annual Meeting handout, the nomination must be received by June 16, 2017.
