Entrance Gate

You may have noticed changing color schemes on the front gate over the last few months as various parties modified the paint in the interest of a more aesthetically pleasing format. Unfortunately, as the saying goes, "beauty is in the eye of the beholder". Suffice it to say that not all were happy with the new "look" of the gate, resulting in over-painting of previous artists' efforts by those who disagreed. As much as we all appreciate the protection offered by the multiple layers of new paint, the Board has received numerous complaints and will consider if a return to the original black/gray color pattern is in order at a future meeting. Further unauthorized painting of the gate will be considered vandalism and may be referred to the Fremont County authorities. The Board is responsible for STB infrastructure, including the gate. so anv modification(s) must be considered and approved by the Board before they are made.

On the evening of 23 July, lightning struck near the gate, destroying some of the electrical components

in one side. Following a similar incident about a year ago, which affected the other side of the gate, a surge protection device was added to the power line during the repair. That device appears to have done its job during the recent strike, as that side of the gate survived unscathed. Additional similar protection was added to the remainder of the gate's electrical components as the recent repair was made, and several ground rods were installed as well. Hopefully, the additional investment of about a hundred dollars will mitigate future replacement of expensive operating devices, at least due to lightning strikes. We all owe Curtis Eulert a big THANK YOU for the hours he spent on both research and labor to repair the gate.

ASK THE BOARD

Q: How can I find copies of the most recent board meeting minutes?

A: Board meeting minutes are posted on the STB web site (www.southtbar.com) in the **Documents** section under **Board Meeting Documents**. The meeting minutes are sorted by date, so the most recent minutes are at the bottom. Please note that the meeting minutes are not posted until after they are approved at the next regular board meeting, so the most recent version available will be at least a month old.

Q: I want more recent information than what is posted on the web site. What's the best way to stay informed about what's going on with the POA?

A: You are welcome to attend any regular or special meeting of the POA board. If you are not able to attend in person, you can call in to the conference call number for that meeting. The conference call numbers are posted on the STB web site before the meeting begins in the Forums section under the Communication from the Board of Directors forum.

Q: How can I find copies of minutes from board meetings that were more than a year ago?

A: Minutes from board meetings that were more than a year old are posted on the STB web site in the **Documents** section under **Archives**. Select the **Board Meeting** archive to see board meeting minutes back to 2006, which is a year before the current web site was implemented.

Q: How can I see board meeting minutes from before 2006?

A: Board meeting minutes from any meetings prior to 2006 are made available upon request from secretary@southtbar.com. Requests for access to POA documents need to use the form provided in the POA's document inspection policy. This policy can be found on the STB web site in the **Documents** section under **Policies/Procedures**, in the **Access to POA Records** document. Please note that many of these older meeting minutes are not available in an electronic form. **Q:** How can I find out who the current board members are?

A: The names and e-mail addresses of the current board members are posted on the STB web site (www.southtbar.com) in the **POA Leadership** section. The information on this page is typically updated with the names of the new board members shortly after the Annual Meeting every year – committee assignments are updated periodically throughout the year.

Q: How can I get a copy of the newest STB member roster?

A: Click on the **Directory** link, sign in, and use the print icon at the top of the document. If you have trouble, contact the webmaster.

Dogs Chasing Wildlife

Every year the Division of Wildlife receives hundreds of complaints of dogs chasing wildlife. Owners don't believe that their pet would chase wildlife. But given the chance, they will follow their instincts and run after deer and elk. Dogs evolved as predators and it is their natural instinct to chase other animals. Deer, fawns and elk calves are especially susceptible to attack shortly after they are born in the spring. Pet owners are legally responsible for damage to wildlife caused by their dog. Owners can be fined \$274 if their animal is harassing wildlife. If a dog kills or injures an animal, an additional fine of \$500 can be levied. All Colorado peace officers are authorized to shoot dogs that are chasing wildlife or livestock. Pets running loose are more likely to be dinner for mountain lions and coyotes. If you see dogs chasing wildlife, contact the local DOW office or any law enforcement agency.


RANCH ROUNDUP
