Eshibit C2 Namer Water Rights

All water and water rights, ditch and ditch rights, wells and well structures, whether adjudicated or not and whether permitted or not, located and used upon the land described in Exhibit A attached hereto and incorporated herein, including but not limited to, Colorado Division of Water Resources Well Fermit No. 104677-A and the following water right adjudicated by Decree of the District Court of Fremont County, Colorado entitled In the Matter of the Priorities of Water Rights in Water District No. 12 entered February 3, 1894 to wit:

The Jack Ditch with an appropriation date of April 30, 1876 and bearing decreed Arkansas River Priority No. 169 and also Middle Fork of Tallahassee Creek Priority No. 4 for the irrigation of eleven acres of land.

Reserving unto Grantor all water and water rights, ditch and ditch rights not specifically granted herein to Grantee including but not limited to the Meadow Ditch. Fear's and all easements and right of way to Grantor to all points of diversion, headgates, ditches, laterals and related structures located on Grantee's property for use upon the property of Grantor.

"The Meadow Fears Ditch will be allowed to divert any amount that is passing the Morning Star Ditch headgate provided the Spring Ditch, the Spring North Ditch, and the Pioneer Ditches are fully satisfied and not calling for water."
